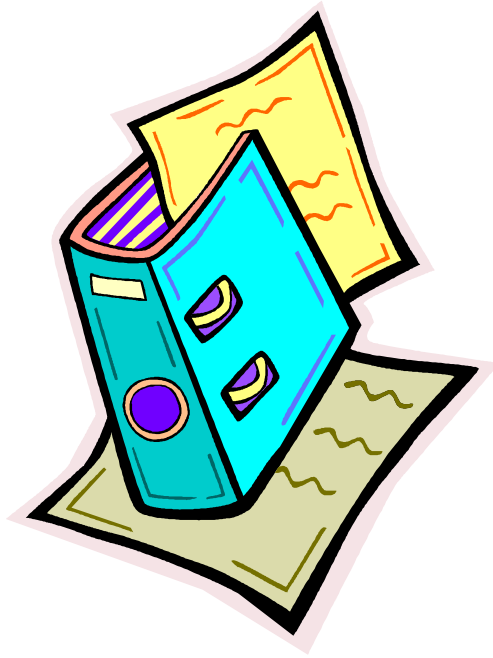


Library Corner November 2009
